F. High School Student Organization Report

Before tonight's Student Organization Report, the Dr. Nagler stated we are committed this year to recognizing our students publicly. He introduced Matt DeLuca, 5th grade teacher and director of the middle school musical. Mr. DeLuca stated this is his 11th year as the middle school musical director. This year the drama club will be performing the first musical he directed, Once On This Island which is the story about a girl from the wrong side of the island in love with a boy from the right side of the island and the people and gods keeping the two apart. Three students each sang a song they will sing in the play. Mr. DeLuca asked all to come see their production on February 3rd and 4th. Mr. DeLuca thanked the district for their continued support. Dr. Nagler stated it never ceases to amaze him how talented our students are.

Ed Escobar stated we are going recognize three sets of students this evening; high school fall all county athletes, 4 high school students who were awarded achievement for the congressional app challenge and students in their narrative writing.

Mr. Ralph Amitrano, Supervisor of the Athletic Department reported Mineola had a great fall season and students had wonderful experiences. Tonight we are going to recognize students who were all county. Several of our teams had a great season lead by these athletes. These students truly dedicate themselves. They practice and train year round. Two of our athletes could not be here tonight because they are at a practice. They were also recognized at their county dinners and our pep rally. We are very proud of our students and they deserve all the accolades. Three coaches attended this evening: Mr. Pereira boys varsity soccer coach, Mr. Cavalluzzo assistant coach boys varsity soccer and Mr. Fretz boys varsity winter track. The students recognized tonight were Allison Mendes, Luis Tinoco, Dimas Cabrera, Brandon Mendes, Gabriel Silva, Matteo Itri, Ryan DeMagistris, Colette Maloney and Samantha Schroeder.

Mr. Smith, high school principal, was asked to speak about the Congressional App Challenge. He thanked the board and Dr. Nagler for supporting this program. Mr. Smith stated this program is the first of its kind on Long Island. This came out of a partnership with Queens Borough Community College. It's a 30 credit certificate program in internet information technology. The goal is for the students to graduate with a high school diploma plus a certificate from Queens Borough college which will get them ready for jobs that are very much in demand in the science area. The program could not be successful without Kuri DiFede teaching the courses the students need for their first year. We are finalizing our plans for year two where the students will actually go to Queens borough for the remaining courses. He explained the Congressional App Challenge by saying 4 students from Mineola high school were selected as a winning team in the 2016 Congressional App Challenge. Announced by members of the US House of

Representatives the challenge promotes the importance of coding and stem education. More than 2000 students participated in this national competition which yielded over 650 original student created apps. Mineola's winning team consists of Bryan Guda, Malcolm Hylton, Joseph Mueller and Vincent Rodrigues. They developed an app called Chow Chow which connects people who are in need of dog sitting services with someone who can take care of the dog. The app users create a profile and fill out a questionnaire. Then the app makes recommended pairing based on location of services. The winners will have the opportunity to showcase their apps to members of congress this april in Washington DC. Congratulations to of Bryan Guda, Malcolm Hylton, Joseph Mueller and Vincent Rodrigues.

Ed Escobar introduced Jodi Helming, the coordinator for writing. This is the first workshop meeting we are recognizing k-4 students. Our K-4 principals are here this evening: Dr. Fleischmann, Ms. Maravel and Dr. Gonzalez. And he thanked all the parents, grandparents and families of the children who are here tonight.

Ms. Helming quoted Beatrix Potter, "There is something delicious about writing the first words of a story. You never quite know they will take you". Ms. Helming reported the students who are being recognized this evening during this presentation have demonstrated a commitment to the writing process. They began by generating ideas in their writer's notebooks. They then selected one of those ideas to develop and wrote a first draft of their personal narratives. They learned and applied various strategies that enabled them to lift the quality of their writing pieces. And finally they prepared their writing for publication. Their final products are representations of themselves as writers and they serve to demonstrate what we have all learned about writing. I has been my honor to work alongside these students and their teachers as well as we have shared this writing journey together.

c. Comments from Superintendent

Dr. Nagler stated it is a great initiative the board asked for this year having our students come to our workshop meetings. Thanked the parents and administrators coming out tonight. He commented on the books on the dais how the writing and punctuation was so nicely done. He stated another board initiative to have Ms. Helming as our full time writing coordinator this school year. Tonight we saw the fruits of that labor. He was very happy to see the children tonight. He stated he visited the fab lab and loved watching the students working and seeing things coming together. Dr. Nagler reported Liz Ryan is applying to west point and the air force academy and has secured her nomination from senator Gillibrand. He is very proud of her and wishes her success.
