**F. High School Student Organization Report - by Molly Donelan**

Molly presented the Student Organization Report this evening. She stated a lot has happened in November. We had our fall drama play, Curious Savage. She named several students who were in the play. Molly reported that State Senator Elaine Phillips came to their S.O. representative meeting to talk about community service. We did the H2O for Puerto Rico Project with her. We had students from the student service center donate bottled water and Senator Phillips got them to Puerto Rico. Molly reported we are having on the spot interviews in the guidance department for any seniors that are interested in having an immediate decision from colleges. We have Adelphi, Hofstra, Farmingdale, Molloy, St. John's, Mercy College and LIU Post are coming. We have concerts coming up which are on the calendar. We have a pep rally tomorrow. Dr. Nagler asked Molly how the first Advisory meeting was and asked her to explain a little about it. She explained everyone in the school is paired with an advisor and it goes by grade. We had our first one this month. We spoke about having a growth mind set and what it means to have a growth mind set and how we can make that stronger. Each teacher is assigned a small group of kids and she thinks it is going to be a good program. We are doing the Follett Challenge again. Last year we won an award and received \$8000 for it.

Dr. Nagler stated Ralph Amitrano has 6 athletes we are going to recognize tonight. These students were All-County Winners for the Fall 2017 Season in their sports. Mr. Amitrano spoke about Nicole Genova, Girls Soccer and Samantha Schroeder, Volleyball, who were unable to attend tonight. He introduced our coaches Coach Pereira, Coach Cavalluzzo and Coach Lenninger.

Paul Pereira thanked everyone for having him and our coaches here tonight. He thinks it is a great idea to recognize our student athletes. He had the honor and privilege of coaching 2 of the young men here tonight, Christian Melendez, Soccer-Honorable Mention from All county and Flabio Anjo, Boys Soccer, Defensive Player of the Year - Scholar Athlete. Paul Pereira announced he is resigning as a soccer coach after 25 years of coaching here in Mineola.

Coach Lenniger coaches Cross Country Track. Ryan DeMagistris and Gabriel Silva were both All-County Winners for the Fall 2017 season. Coach Lenninger praised the boys.

On behalf of the Board, Dr. Nagler thanked coach Pereira for all his years of coaching.

**G. BOE Reports**

**a. Comments from Board Trustees**

Patrick Talty started by saying he has late breaking news - the 8th grade Girls' Volleyball Team beat Garden

City just a little while ago. He said a few weeks ago he had the privilege of attending our district's unveiling of a Read to Succeed program which is an early literacy program and we use an app called Footsteps to Brilliance. It's a unique program because it doesn't wait for the children to get into the school system. He attended the Friday evening show of Curious Savage. It was a fantastic story and the final scene blew him away. He said our students did a fantastic job. He congratulated Matt DeLuca, Bette Sloane and all the cast and crew.

Cheryl Lampasona reported that last night she attended the Gingerbread University at Hampton Street that the PTA sponsored . She said there were over 40 families in attendance. The new gym at Hampton was packed. There were kids making gingerbread houses along with grandparents making gingerbread houses. There was hot chocolate and Christmas caroles. She said it was a really nice event in our new gym. Everyone helped clean up which was also very nice to see.

Brian Widman - No report tonight.

Dr. Margaret Ballantyne-Mannion reported she went to the Narrative Writing Celebration at Meadow Drive. She really enjoyed the time she spent at Meadow. She started out in a dual language class and she sat at a table with an English speaking family and a Spanish speaking family. The children read in both languages. We are very proud of their work. It was so beautifully organized. There were stories they wrote and stories on their ipads. They had a craft to do based on their stories. They had written a poem about what was on their Thanksgiving plate. They also wrote a story about a day in the summer. You could see the children's pride and the parents pride in seeing their children becoming authors. The staff did a wonderful job. Dr. Ballantyne-Mannion stated she is looking forward to what will be her first holiday activity - the SEPTA party on Saturday morning in the Jackson gym. It is for every child in the district it is not just for children who are in special education. SEPTA opens it up to the entire district. It is always a great party and a special day.

#### **b. Comments from Board President**

Christine Napolitano stated it has been a very busy two weeks since our last board meeting. She had the distinct pleasure of attending our Future Ready Library presentation yesterday at Hampton Street. It was a packed house. We had a lot of districts send their librarians over basically to see what we as a district are doing in our libraries. All the administrators were there. And the best part was we had a lot of our students there. Dr. Nagler gave his presentation and showed an interesting Ted talk about librarians and the future of libraries. Ms. Napolitano found these very interesting seeing where Mineola is was very exciting. She could hear a lot of the librarians talking about our district and they were just 'wow'd' by everything they saw. What she really found so interesting it sort of is a by product of everything we do here. Our kids are tremendous from the youngest to the oldest. They are so comfortable speaking to strangers in a very adult-like way explaining to adults what they are doing. She could not be more proud of our students. It was a really exciting day. She thinks a lot of school districts took a lot away with them. She feels we inspired them greatly. She said thank you to everyone involved with this. She said she had the distinct pleasure of attending a holiday fun night Angelina's with the PTAs. I hope that we continue this tradition. She really enjoyed it and said it was a lot of fun. She loved the bingo. She felt that it was so nice to get administrators, principals, moms and board members all together to get to know each other better.

#### **c. Comments from Superintendent**

Dr. Nagler stated that the last board meeting, November 9th, was the first board meeting he has missed in 9 years of being superintendent and he said he did not like it. He watched the meeting on Livestream and stated he is back where he belongs. Dr. Nagler said he was away receiving an award on behalf of the district. We applied for and received recognition to be part of one of the 25 most innovative schools in our country. It is sponsored by AASA which is the Superintendent's National Organization as well as the School Partner Network, SPN. These two organizations teamed up together and they are going to be writing case studies about districts throughout the country and unveil those at the annual meeting of AASA in February. Dr. Nagler stated he will be presenting at the meeting and he is looking forward to see how our case study is written. He reported Dr. Jones spent 2 days here, most of the day at the high school speaking to kids, teachers and then walking the buildings. He went to every building with the exception of Meadow and really got a feel for our district. Dr. Nagler shared what Mr. Jones wrote to all the administrators - *"I left very impressed with the learning environment you have created at Mineola. I have become a strong advocate for what you are developing, you should be MineolaProud. When I left yesterday afternoon talking with Mike, Matt and Margarita, I thought of the phrase "a cognitively-engaged school" which seems to be a good description not quite as good as the 7th grade student who described the middle school as "magical." I don't see that very often. I hope I can capture in the case study the impressive observations."* Dr. Nagler said that this is an interesting validation from a person who has been in the business for 40 something years whose job is to coach districts and observe districts.

Dr. Nagler spoke about our Future Ready Library symposium. He stated he is the president elect of Nassau County Superintendents and he also chairs their technology committee, so as part of his work on the technology committee they developed collectively this symposium. They just decided to hold it in our district because he thinks we are far enough along to showcase what a future ready library looks like. We had 21 districts and over 80 people here. The vast majority of them were librarians. He has been receiving emails since yesterday from administrators, other superintendents, and other librarians, all with praise and a little jealousy of what they've seen here in Mineola.

Dr. Nagler spoke about expanding our drama program.

Dr. Nagler reported that Mr. Gaven and Mr. Escobar attended a meeting with him at Adelphi on Wednesday regarding their residency program. Adelphi is a little nervous about the sustainability of the program the way it currently exists. So we are going to be brain-storming some possible changes or additions to it. We are in conversation with BOCES that perhaps we can make a coser for the residency program to enable us to keep the residents for a full year and perhaps a year after which is a way to feed our vacant positions and/or perm sub positions. More information will follow.

Dr. Nagler went on to speak about the ipad nights at Meadow and Hampton. He attended and showed us a chart showing the parents experiences with all the different apps and way the children learn. There was a good turn out and they did a great job.

Patrick Talty asked Dr. Nagler to explain why Adelphi is concerned about the sustainability of the residency program. Dr. Nagler stated it is a big commitment for the college student to be here every day for an entire year and go to classes. Most of them need some kind of income. If they were in a traditional program they would have plenty of time to have a job and make money.

**H. Old Business** - Christine Napolitano had some old business. She started a discussion on the possibility of later start times for the high school. She stated a couple of weeks ago we received an email from a resident asking us about visiting the topic of a later start time at the high school. We have talked about this before. Dr. Nagler said some high schools flipped where the older students start later and the younger students start earlier which he feels makes a lot of sense. He said younger children are usually up early and ready to go where as teenagers are harder to get up. The stumbling blocks typically are our young parents do not like the early start time primarily because it is dark at the bus stop for a good part of the year and they don't know what to do with the the younger students when they get home. If the younger students get home early there is a problem with childcare until parents get home. We could form a committee to discuss changing the start times.
