RESOLUTION #67 - Adopting A Negative Declaration in Connection with Proposed Renovations at Mineola Middle School

WHEREAS, the Board of Education of the Mineola Union Free School District (the "Board") the is proposing to undertake a variety of capital projects at the Mineola Middle School: (a) replace the roof system over the Mineola Middle School Auditorium and removal, replacement or patching over of the existing skylight in the Auditorium's roof, including if needed replacement of gutters, installing insulation, painting wood trim, connecting downspouts, and abatement of materials; (b) converting an existing baseball field to a synthetic turf baseball field, including dugouts, retaining walls, fencing, lighting, plumbing, spectator seating, landscaping at Mineola Middle School and (c) retaining walls, concrete, asphalt, fencing and rails associated with the entry way of the art rooms at Mineola Middle School (collectively, the "Proposed Projects"); and

WHEREAS, the Proposed Projects are classified as an Unlisted Action under SEQRA and the Board performed an uncoordinated review; and

WHEREAS, through the assistance of H2M Architects, Engineers, Land Surveying and Landscape Architecture, D.P.C., the Board has completed and reviewed Parts 1, 2 and 3 of the EAF and supplemental information for the Project; and

WHEREAS, the Board has conducted an environmental review of the Project pursuant to SEQRA;

NOW, THEREFORE, BE IT RESOLVED that the Board, in accordance with 6 NYCRR Part 617 and upon review of the Short Environmental Assessment Form and all other materials prepared, has identified and analyzed the relevant areas of environmental concern to determine if the Project may have one or more significant adverse environmental impacts and for the reasons set forth in Part 3 of the EAF, hereby finds that the Project will not result in any significant adverse environmental impacts and adopts and authorizes the Assistant Superintendent for Business and Operations to execute Part 3 of the EAF for the Proposed Projects at Mineola Middle School; and
